1. **DEFINITIONS**:

- 1.1. MFA: MFA in this agreement implies MSPARK Futuristics & Associates.
- **1.2. GLBITM:** GLBITM in this agreement implies G.L. Bajaj Institute of Technology & Management, Greater Noida.

2. BACKGROUND & OBJECTIVES:

- 2.1. MFA is an engineering firm, providing consultancy services for all infrastructure projects. The Key strength of the firm is to provide services right from pre tendering to feasibility study of all kind of projects, tendering for projects, rate analysis, business promotion related to infrastructure & civil construction for new entrepreneurs by facilitating to manage credentials for them. 3.2. Responsibilities of MFA:

- 3.2.3. Provide IS code.
- **3.2.4.** Help in coordination in case any support is required during the work.
- 3.2.5. A pilot project for training of the student will be done
- **3.2.6.** Possible help related to placement of suitable /trained student

4. Intellectual Property Rights:
