Roles and Responsibilities of Drug-Free Committee Members

- Organize awareness programmes, rallies, poster campaigns, street plays, and meetings on the harmful effects of drugs, alcohol, tobacco, and other substances.
- Promote healthy lifestyles, sports, yoga, and cultural activities as alternatives to substance use.
- Spread information about NMBA objectives and government initiatives.
- Work closely with schools, colleges, Panchayats, NGOs, and local institutions.
- Help identify individuals at risk of substance abuse in a sensitive and non-judgmental manner.
- Encourage early counseling and support rather than punishment or stigma.
- Refer affected individuals to appropriate de-addiction, counseling, or rehabilitation services.
- Facilitate access to government-recognized de-addiction centres, hospitals, or NGOs.
- Monitor local areas for substance abuse-related activities and trends.
- Report concerns to local authorities or coordinating agencies as per guidelines.
- Maintain records of activities, meetings, and outcomes related to NMBA programmes.
- Coordinate with district administration, social welfare departments, health departments, and law enforcement (within legal and ethical limits).
- Reinforce the message that addiction is a health and social issue, not a moral failure.
- Act as role models by leading a substance-free life.
