Purpose:

The aim of the cell to ensure equitable access to quality higher education for students belonging to Socio-Economically Disadvantaged Groups (SEDGs) in accordance with the National Education Policy (NEP) 2020 and the Sustainable Development Goals (SDGs).

1. Identification of SEDGs

SEDGs include individuals facing social, economic, cultural, or locational disadvantages such as:

- **Gender identities** women and transgender persons
- Socially backward groups SCs, STs
- Economically and educationally disadvantaged groups Non-Creamy Layer OBCs, EWS, firstgeneration learners, students from vernacular backgrounds
- Minorities religious and linguistic
- Persons with Disabilities (PwDs) as per RPwD Act, 2016
- Vulnerable communities BPL families, migrants, orphans, victims of trafficking
- Disadvantaged locations rural, tribal, aspirational districts, border/conflict/disaster-prone areas

2. Establishment of SEDGs Cell

SEDGs Cell functioning independently to:

- Protect constitutional rights and ensure safety and dignity of SEDG students.
- Implement government policies and UGC schemes effectively.
- Provide counselling, mentorship, and academic support.
- Redress grievances within 15 days through a dedicated committee.
- Maintain data, monitor welfare facilities, and publicize support schemes.
