INFORMATION FOR THE FACULTY:

- 1. Prepare date-wise lecture plan, submit to the respective HOD before to commencement of classes & attach a copy in course file of the subject.
- 2. The attendance should be uploaded on the SIM / Web Portal on daily basis.
- 3. Answer sheets of Sessional Test /PUT should be evaluated and shown to the students within three days and ensure the uploading of marks on the SIM.
- 4. No class should be left unattended as per the time table but if inevitable then proper intimation to HOD is must.
- 5. All are required to take proper prior permission from respective HOD before availing any type of leave. Avoid pre-fix OR suffix type of leaves.
- 6. Invigilation duty is mandatory as per the schedule given by exam cell. In case of any absence, a substitute must be provided by the concerned faculty.

GUIDELINES TO THE STUDENTS

- 1. Students registering themselves after commencement of classes shall be liable to deposit the fine (Rs100/- per day w.e.f. date of registration).
- 2. Duration of Sessional tests / PUT will be 2 or 3 hrs. (ST1 from two units and PUT from the whole syllabus).
- 3. All are required to maintain minimum 75% of attendance (in each theory and practical subjects) for appearing in sessional tests / PUT. List of students having shortage of attendance will be displayed on the departmental notice board before commencement of each exam.
- 4. Minimum 75% overall attendance is required to appear in the University End Semester examination as per university guidelines.
- 5. Generally extra classes will not be conducted, therefore, student are required to maintain their attendance in regular classes only
- 6. RAGGING is a punishable offence, all are required to refrain from it. FIR shall be lodged against culprit, as per order of Hon'ble Supreme Court.
